Livestock Sector Investment and Policy Toolkit (LSIPT) WebApp



Terms of use

The LSIPT WebApp (hereinafter referred to as "*the Platform*") is an open-access, web-based platform designed to collect and analyze data on livestock production systems ("*Data*"). It provides insight into the current and projected contributions of the livestock sector in terms of production, poverty reduction, and food security, and assesses the impact of interventions and investment scenarios. The Platform supports evidence-based policymaking and strategic investment in the livestock sector for its sustainable transformation.

The Platform is a web-based adaptation of an Excel-based tool originally developed by the French Agricultural Research Centre for International Development (CIRAD) in collaboration with FAO and the World Bank. The adaptation was led by FAO to create a user-friendly interface for broader public use. The Platform is available in English, French and Spanish.

User account and access

- Access to the Platform requires the creation of a User account, which consists of a username (email address) and a password.
- The User is responsible for the safekeeping of this access information. The User may not sell, share, or publish their access information.
- By registering for and accessing the Platform, the User confirms that they have read, understood, and accepted these Terms of Use.
- The User also acknowledges that they have fully read and understood the [FAO Data Protection and Privacy Notice](#) and agree to its terms, which apply to users of this Platform, except as otherwise provided in these Terms.

Open access and use

- The Platform is provided as a free, open-access tool for public use.
- Users may freely access and use the functionalities of the Platform for purposes consistent with its intended mission, including research, policy analysis, and educational purposes.

Projects and data sharing

- Each *Project* created by a User produces a data-driven analysis of the livestock sector for a geographical scope (subnational, national, regional) of one or more animal species.
- Any User may share Projects with other Users of the Platform, granting them access to input data, analytical results, and modification rights. All Users with access to a shared Project can view and edit its data. Changes made are visible to all collaborators.
- FAO does not claim ownership of the data uploaded by Users and will not use, disseminate, or incorporate such data into other work unless explicitly shared by the User through project collaboration.
- FAO may use aggregated and anonymized data from the Platform to report on usage statistics and other types of aggregated metrics. These reports will not be used to disclose any details of specific projects.
- The Platform does not contain personal identifiable data, and User is discouraged from entering any personal or sensitive data in the *Project* created by User.

Intellectual property and attribution

- All intellectual property rights related to the Platform's structure, design, and code are retained by FAO and its development partners.
- Data uploaded by Users remains the property of the respective Users.
- Users are encouraged to acknowledge the LSIPT WebApp in any public output or publication resulting from its use.

Liability disclaimer

- FAO makes the Platform available “as is”, without warranty of any kind.
- FAO is not liable for any loss or damage—direct, indirect, incidental, or consequential—arising from the use of, or inability to use, the Platform or from reliance on its outputs.
- Users are solely responsible for the interpretation and application of results generated by the Platform.

Geographic and institutional neutrality

- The designations of countries or regions used in the Platform do not imply any opinion by FAO on the legal status of any territory, or endorsement of its authorities, boundaries, or frontiers.
